Company performance

Limited operations recommenced in compliance with Lagos State COVID-19 restrictions. The hotel opened on 1 September and the casino on 10 September 2020. The trading results reported in condensed unaudited financial statements are not comparable with the same period in the previous year.

The Company has invested in materials, equipment and training to maintain a hygienic and safe environment to prevent the transmission of COVID-19. The demand for hospitality services remains low. The safe environment created within the casino has seen casino revenue recover at a stronger pace than hospitality, but below normal trading levels. Total revenue decreased 69% compared to the same period in the previous year.

Controlled direct expenses reduced 30% compared to the prior period. Unrealised foreign exchange losses of \\$4,632m were incurred on loans, resulting in a loss before tax of \\$6,173m for the period under review, compared to a loss of \\$1,402m in the previous period.
