Company performance

The Company complied with the government enforced lockdown effective from 31 March 2020, whereas the Company traded for the full six month period under review, although current trading remains impacted by difficult trading circumstances and ongoing compliance with specific COVID-19 regulatory restrictions. The trading results reported in the condensed unaudited financial statements are therefore not entirely comparable with the same period in the previous year.

The Company's revenue increased by 79% compared to the same period in the previous year. Casino and hospitality revenues increased by 210% and 14% respectively.

Controlled direct expenses excluding depreciation increased 27% compared to the prior period. Unrealised foreign exchange losses of N700m were incurred on shareholder and related party loans as compared to a loss of N3,661m in the prior period, resulting in a loss before tax of N1,315m for the period under review, compared to a loss of N4,505m in the previous period.
