Company performance

The Company complied with the COVID-19 regulatory restrictions from March 2020. The restrictions were revised from time to time. The impact of some of the restrictions on the operations of the business has distorted some of the comparative financial reporting.

While trading conditions remain challenging, the Company's revenue increased by 48% compared to the same period in the previous year. Casino and hospitality revenues increased by 2% and 114% respectively.

Controlled direct expenses excluding depreciation increased 21% compared to the prior period. Unrealised foreign exchange profits of N544m were earned on shareholder and related party loans as compared to a loss of N494m in the prior period, resulting in a profit before tax of N4212m for the period under review, compared to a loss of N4876m in the previous period.
