

- 2. An order of this Honourable Court sanctioning the already-made appointment of Messrs. Seyi Akinwunmi and Okorie Kalu ("the




nominees") as Nominees for the proposed CVA.

- 5. That this case is hereby adjourned to the 12<sup>th</sup> day of January 2022 for the consideration of the Report of the said meeting for the Court's further intervention.
