Company performance
While trading conditions remain challenging, the Company's revenue increased by 22% compared to the same period in the previous year.
Casino revenues decreased by 21% whilst hospitality revenues increased by 24%.

Controlled direct expenses excluding depreciation increased 25% compared to the prior period. Unrealised foreign exchange loss of \mathbb{H}924m were earned on shareholder and related party loans as compared to a loss of \mathbb{H}862m in the prior period, resulting in a loss before tax of \mathbb{H}1,736m for the period under review, compared to a loss of \mathbb{H}1,559m in the previous period.
